The following Terms & Conditions govern the JAX Tyres & Auto Promotion & apply as between an Entrant, the Promoter and the applicable Participating Store.

### **Terms and Conditions**

#### **General**

1. The JAX Tyres & Auto Promotion is available online and in Participating Stores during the Promotional Period. Local store trading times apply.

#### **Eligibility**
